



#### Latino Decisions New Mexico Census Outreach Survey (July, 2019)

(Results of Native American Sample N= 100)

The following results are based on the 100 respondents who self-identified as Native American or American Indian to the statewide Census Outreach Survey conducted in July of 2019. The survey was intended to identify potential obstacles to a high participation rate for NM Census 2020, and strategies to help ensure we have high participation. Below are the percentages for Native American/American Indian respondents for each question of the survey that included this sub-group of the sample. A full methodology statement is provided at the bottom of this document. The Native American Budget and Policy Institute pulled out the Native American specific numbers included here on behalf of the Indian Affairs Department of the State of New Mexico.

#### Methodol ogy:

On behalf of the Census Funders Group/NM Counts 2020 (who do we list as the funders/organizers), Latino Decisions completed 960 interviews from July 3, 2019 to July 21, 2019. Interviews were collected via landline phones, cell phones, and the web. The phone portion was conducted by live interviewers who were bilingual and administered the survey in the language of preference of respondents, and web-based interviews were also able to be conducted in English or Spanish. Of the full sample 37% of respondents were Hispanic, 44% non-Hispanic White, and 10% Native American, and the remaining percentage comprised of African American and Asian American resident of New Mexico. The full data are weighted to match the population in New Mexico across the following key demographic indicators of gender, education, nativity, ancestry, and race/ethnicity. A post stratification raking algorithm was used to balance each category according to the 2017 ACS 1-year data. The survey carries a margin of errors of +/- 3.16 points for questions asked of the full sample and had median completion time of 20 minutes. More information about the survey is available here:
